For over 20 years, Dr. Martín has led evaluation, research, and policy analysis for federal, state, and civil-sector entities in the fields of energy efficiency, climate mitigation and adaptation disaster management and recovery, and energy and environmental justice in relation to housing construction, design, and quality.
